1Q FY2013

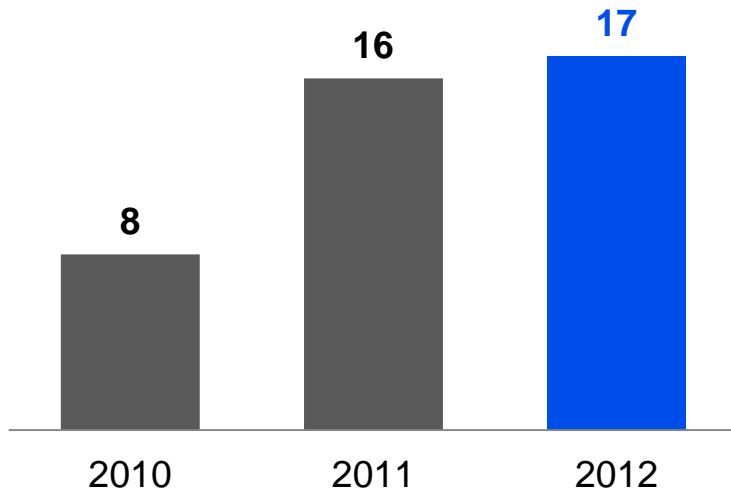
- **PAT up 12.5%** to RM9.0 mil
